SRI SIVANI UNNATA VIDYA SCHOLARSHIP

MOTIVE:

Sri Sivani college of Pharmacy Offers B. Pharm and M. Pharm pharmacy programmes. The primary aim of this policy is to provide the financial assistance to the students who are not eligible for JVD scheme.

SCOPE:

The purpose of this document is to establish and formalize the hostel fee waiver policy under the “**SRI SIVANI UNNATA VIDYA SCHOLARSHIP**” for cohorts commencing their studies in 2018 and beyond, encompassing all programs provided by **SRI SIVANI COLLEGE OF PHARMACY**. It is important to note that this policy does not delineate the admission criteria; such criteria are distinct and are communicated through separate admission notifications for each academic year.

POLICY STATEMENT:

In this program, Rs 5,000/- will be waived for the students in their Hostel fee or Bus fee or in Tuition fee of concerned programmes ie including both Pharmacy and Pharmacy. The objective of this policy is to alleviate fee to the students who are not eligible for JVD scheme. As an incentive to enrolled student’s the policy reduces the financial burden by offering them a discount equivalent to the specified amount on their fees.

PROCEDURE:

Among the enrolled students, a fee waiver is provided to those who do not receive any scholarships through JVD Scheme and enrolling in various programs, such as Pharmacy and Pharmacy.

STUDENT ETIQUETTE:

The Tuition fee or bus fee or the hostel fee is an exemption applies to the one academic year B. Pharmacy and M. Pharmacy programs offered by the college, for extension of the scholarship the students need to apply for the next academic year. This benefit is contingent upon the students maintaining good behaviour within both the hostel and college premises.

A student who is benefiting from the tuition fee waiver fail to adhere to the established code of conduct, they will lose their eligibility for the fee waiver for the current semester and any subsequent semesters. Instances of such misconduct will be promptly reported to the college's head authority by the hostel warden and hostel supervisors, accompanied by concrete evidence. A comprehensive enquiry will be conducted before any final decisions are reached.
