### 13. MEMBERSHIP

The Members of SRIKAKULAM TOWN and the members of other Regions shall have membership in this Society. Every member shall have to pay Rs. 100/- per month towards subscription. The Membership shall have to be accepted by the Executive Body. The Executive Body shall have the right to change the subscription. From the date of obtaining membership, the member shall abide by the rules and regulations of the society as well as General Body Resolutions. The Executive Committee shall have the power to take disciplinary action against any member or members who are against shall have the power to increase or decrease the moveable or immoveable properties in view of the developmental activities of the Society. The activities of the Association shall spread over the entire District.

### 14. DISQUALIFICATION TO BE A MEMBER :

The Membership of the above noted persons shall be forfeited and the membership shall be restored with the acceptance of the Executive Body.

### 16. GENERAL BODY - RESPONNSIBILITIES :

As per the Article 3 above all the subscribers shall be the members to the General Body. The General Body Meeting shall be convened in the month of NOVEMBER every year. If any additions are delections in the existing Bye-Laws of the Society are requierd to be amended, shall be amended by passing separate resolutins to effect of the following :

## 07 EXECUTIVE BODY - RESPONSIBILITIES

The Executive Body shall consist of 18 members. Among them President, Vice-President, Secretary, Joint Secretary and Treasurer shall be elected and the rest of 12 members shall act as Elective Members. The E.C. Members shall have to be elected once in 2 years by General Body. If any vacancy arises in the E.C. in between the term, the Executive Body shall elect to fillup the vacancy from out of General Body Members. The E.C. Meeting shall generally meet once in 3 months or on the dates fixed by the Secretary. Prior Notice of 3 clear days shall be served on the E.C. Members for such meeting. The Executive Committee shall have power to enhance the members as per the need and necessity and also to establish a Branch of the Association somewhere else.

## DISPUTES

Any dispute arises in between the members and in between the members and out-siders shall be settled by arbitration. If it is not possible such dispute or disputes shall be dealt with as per Section 23 of A.P. Societies registration Act 35 of 2001.

## 09. MORTGAGES AND EXPENDITURE ( BAD- DEBTS)

All such mortgages shall be recorded in the books concerned to the Association and shall be kept open all the members for verification without charging any fees, for the same. If the Society is indebted, such debts shall be cleared off by individually or combinedly or jointly.
